PAYMENT DETAILS

THE **CATAMARAN** COMPANY will automatically charge your credit card on file for advance payments.

Please contact us at least 5 days prior to your next payment if additional credit card information needs to be submitted.

If preferred payment is by check, please contact us prior to your next payment. Late fee of \$50.00 will be applied for payments not received by due date.

- A deposit of 25 % of the charter fee is required to confirm your charter.
- Upon receipt of your deposit, a confirmation package will be mailed or e-mailed to you.
- Additional payments are due 90 days prior to your departure date.
- Final payment is due 45 days prior to your departure. This includes all additional options.

Cancellation Policy

In the event that you need to cancel your vacation for any reason, please contact THE **CATAMARAN** COMPANY. Please review the following cancellation policy. Please note this policy applies regardless of the date of reservation was confirmed.

- Cancel 90 days prior to departure and a fee of \$300 WILL APPLY
- Cancel 46 - 89 days prior to departure and 25 % deposit is lost
- Cancel 45 days or less there is no refund given

Trip Protection Program

You invest a lot of time and money in your charter vacation. That's why we are pleased to offer our Trip Protection Program. This special coverage protects your investment both prior and during your charter vacation. The protection program covers cancellations, postponements and charter interruptions listed on the booklet provided online or in your package. The premium for this safety net is only 7% of the total charter cost.

THE **CATAMARAN** COMPANY's Trip Protection plan highlights include:

- Charter cancellation such as medical emergency, sudden serious illness, injury to crew member or immediate family members.
- Allows postponement and charter interruptions. If a cancellation occurs under the terms & conditions of our program listed in **STEP 6**, then **REFUNDS AND CREDITS** can be allocated.
- If a crew member such as the captain/skipper or first mate listed on your sailing resume is forced to cancel due to medical emergency, The Catamaran Company will hire a crew at no additional expense to you.

IMPORTANT

Coverage automatically remains in force if the insurance is **NOT** declined within 30 days of your initial deposit was received. Please sign and return the **TRIP PROTECTION FORM** if you do not wish to accept our trip protection program. Refer to **Step 6** for further explanation.

Since the terms for automatic payment are clearly stated upon initial booking, a processing fee of \$50 per transaction will be charged for refunds requested due to failure of notification to the Catamaran Company.
