PAYMENT DETAILS

THE **CATAMARAN** COMPANY will automatically charge your credit card on file for advance payments.

Please contact us at least 5 days prior to your next payment if additional credit card information needs to be submitted.

If preferred payment is by check, please contact us prior to your next payment. Late fee of \$50.00 will be applied for payments not received by due date.

- A deposit and signed charter agreement are needed to confirm your charter
- 25% deposit if charter is more than 6 months away: 25% 6 months prior to charter: 50% 45 days prior to charter

OR

- 50% deposit if charter is within 6 months, 50% 45 days prior to charter.

Cancellation Policy

Cancellation: It is further agreed by the parties hereto that IF THE CHARTERER MUST CANCEL, ALL MONIES WILL BE FORFEITED unless the yacht is re-booked for the original dates booked. Refund will be in full or pro-rated according to dates re-booked less 15% cancellation fee. If the Owner must cancel, the Owner shall refund monies paid in full to the Charterer and the Owner shall pay the broker the full commission on the full charter amount. Cancellation must be done by facsimile or by registered mail.
